

TRIAXES SOFTWARE LEGAL USAGE TERMS

Software ("Software") released under the trademark Triaxes is a commercial product. The Triaxes Software license will be provided to the customer ("Licensee") for the total value of the product. The terms and conditions are described in this License Agreement ("EULA").

The demo version of Software is designed and can be used only to evaluate the functionality of Software. Any commercial use of the demo version, its sale, modification and combination with third-party software is not allowed.

END USER LICENSE AGREEMENT

This EULA is a legal agreement between you ("Licensee") and Triaxes Line LLC, a company duly incorporated under the laws of the Russian Federation ("Licensor") for the Triaxes Software ("Software") that accompanies this EULA including associated media, hardware protection and activation keys, printed matter or any embedded or electronic documentation.

Proprietary rights to Software, images, texts and instructions contained in Software, belong to Licensor solely. The right to use Software for any purpose is granted to Licensee and shall be subject to the following conditions and restrictions:

1. EXTENT OF LICENSE

- 1.1. The EULA permits Licensee to use one (1) copy of Software on one PC.
- 1.2. The EULA permits Licensee to create one (1) back-up copy of Software and install this back-up copy on a portable or personal computer.
- 1.3. Licensee may not use Software on a multi-user network and grant sublicenses or rights to Software to any third-party. The option of using Software on a multi-user system requires a separate license.

2. LICENSE AND RESTRICTIONS

- 2.1. Licensee shall not undertake reverse engineering, decompile, disassemble, translate, change the structure, modify Software, and create derivative works based on Software, except and only to the extent that such activity is expressly permitted by applicable laws notwithstanding this provision.
- 2.2. Licensee may not distribute Software. Distribution means providing access to third parties to the components of Software by network or other ways, as well as by sale, rent and transfer for temporary use.
- 2.3. Software is licensed as a single product. You may not unbundle the component parts of Software for use on separate computers;
- 2.4. The term of this EULA shall not be limited in compliance with its terms. In case of violation of this EULA, Licensor may terminate this EULA, in which case Licensee shall return Software, including all component parts, media, printed materials, any improvements and updates and destroy all back-up copies of Software.

3. UPDATE AND TECHNICAL SUPPORT POLICY

- 3.1. Licensor provides technical support for all licensed copies of Software, but reserves the right to determine the timing and amount of assistance provided. Licensor has the right to request Licensee's data required for the implementation of technical support. In case of refusal to provide these data technical support may not be possible.
- 3.2. The update is performed only for licensed copies of Software. Licensor independently establishes the timing and conditions for Software updates. Licensee may choose whether to do a Software update or not.
- 3.3. Licensor grants free updates of Software for 12 months from the date of purchase of the original version. At the end of 12 months from the basic Software purchase date updates are available at an additional charge.

4. LIMITED GUARANTEE

- 4.1. In accordance with Russian legislation and rules of international trade law Licensor provides the following guarantees:
 - 4.1.1. media, as well as the documentation, do not have physical defects, which can make them unusable;
 - 4.1.2. Software on the storage media and internet sites is provided in accordance with the documentation;
 - 4.1.3. Guardant hardware protection keys have warranty of the manufacturer.
- 4.2. Licensor guarantees the normal operation of Software within one (1) year from the date of purchase. "Normal" operation means the operation of Software in accordance with the accompanying documentation.
- 4.3. In case of defects within the specified warranty period, Licensor agrees to replace Software for free in the event that the detected defects did not occur due to improper storage or use of the media, or computer Software.
- 4.4. In case of Software defects after the termination of the warranty period, Licensor agrees to replace Software on concessional terms.
- 4.5. Licensor warrants to Licensee preferential purchase of new versions of Software at a discount.
- 4.6. In accordance with the internationally accepted principle of Software trading, "AS IS", all the claims to the functioning of Software, as well as incompatibility with a particular hardware configuration PC does not constitute grounds for filing a complaint. Licensor does not warrant that Software does not contain errors and is not responsible for direct and indirect effects of Software usage.
- 4.7. Licensor shall under no circumstances be liable for any damages (including, without limitation, loss of profits, business interruption, loss of business information, or other pecuniary loss) arising from the use or inability to use Software, even if the Licensor has been advised of the possibility of such loss.

5. DEMONSTRATION VERSION OF SOFTWARE

5.1. The demo version of Software and documentation are freely available to download and install from the web-site <http://www.triaxes.com>. Licensor recommends to install the demo version of Software and get acquainted with the documentation before purchasing Software, and make sure that Software meets the requirements and objectives of the Licensee.

6. ACTIVATION CODE

6.1. This EULA is also applied to the Activation Code. Activation code changes the demo mode of Software into the fully functional Software mode. The Activation code is issued to the Licensee personally and cannot be transferred to third parties. Transferring of the Activation code to third parties leads to a violation of this EULA.

7. By purchasing, installing, copying, or otherwise using Software, Licensee unconditionally accepts all the terms of this EULA.
